#### Mutual-12 President's Report March 14, 2024



- 1. A sad note, we lost a very good friend, colleague and Mutual Director in Mr. Daniel Addis who recently passed away. The board will advise of any future services when known.
- 2. As a reminder, your board follows a code of conduct in dealing with GRF staff, and your mutual board members. We appreciate that our shareholders are respecting all staff and board members.
- 3. We need to remember the service companies we have contracted to work in M-12, such as "4-Star Landscape" and others. These service companies report to your board, not to individual shareholders. Please remember if you have any issues with any of our contractors, bring them to the attention of your board members. Please do not approach these employees with complaints or suggestions. This causes confusion and slows their progress to complete whatever we have contracted them to do.
- 4. I have been advised that our Inspector will continue to secure an <u>updated</u> roofing schedule for us as soon as the roofing company can supply one. As you may know the roofing company is working on other mutuals as well as ours. We have asked to have buildings identified as to when the roofs will be replace. Shareholders have identified termite rot that need to be fixed. Our inspector knows of these. These will be taken care of during the repair process of the new roofs or shortly after.

- 5. With the exception of a few units, our fire inspections have been completed. Letters have been sent to the Shareholders who were identified as needing "work". These Shareholders will be reinspected in the near future.
- Carport inspections have been completed. Letters have be sent to those Shareholders who need to bring their carports within policy 12-7502-1 compliance. We wish to thank all shareholders on doing an excellent job in cleaning up our carports. This keeps our insruance company happy.
- 7. I have had a few questions about Directors not returning shareholders' phone calls. If you call <u>any</u> Director and they do not answer, you should always <u>leave a message</u>. I have received many calls without a message being left for a callback. In my personal case, if your phone used to call me has an area code other than 310, 562 or 714, my system will automatically send your phone number to SPAM, and I may never know you called. - 2. Proof of liability insurance

**DOGS** need to be registered with the Seal Beach Police Dept. Please go to their web site and preregister your dog's information, to get your dog's Seal Beach License.
